ENERGY COUNCIL (20-21 MARCH) - CONCLUSIONS

The European Council took place on 20 and 21 March in Brussels.

The Council held a first policy debate on the framework for climate and energy in the period from 2020 to 2030 and agreed on the way forward.

Ministers underlined the important link between the Europe 2020 strategy, industrial competitiveness and climate and energy policies.

ENERGY COUNCIL (4 MARCH): POLICY DEBATE ON 2030 FRAMEWORK ENERGY COMMUNICATIONS

The Energy Council which took place on 4th March, held a public policy on the Commission debate communications on "Energy prices and costs in Europe" and "A 2030 framework for climate and energy policy". Ministers stressed, particular, that future climate and energy policies should aim to balance different objectives: sustainability, affordable energy prices (especially

for vulnerable consumers), safe and secure energy systems and European competitiveness flexibility for member states and a fair distribution of efforts were underlined. The Council also insisted on the need to benchmark network costs and identify best practices.

ENERGY COUNCIL (28 FEBRUARY): DIRECTIVE ON MEASURES TO REDUCE THE COST OF DEPLOYMENT OF HIGHT-SPEED COMMUNICATION NETWORKS

On 28 February, a compromise was reached for the Directive on measures to reduce the cost of the deployment of high-speed communication networks. The European Parliament and Council agreed on the Directive as legal format. Some more reciprocity — as requested by CEDEC — have been added to the text as well as

some clarifications on the costs that these measures might entail. The European Parliament will now vote on this compromise in its April plenary session. The Telecom Council will decide on adoption of the text in June.
