CEDEC PRESENTS ITS POSITION ON ENERGY MARKET DESIGN

The public consultations that came together with the European Commission's Communication on Delivering new deal for energy consumers, aim to integrate an Energy Union strategy able to match the 2030 energy and climate targets. As the role for customers, citizens and local actors
