### **EUROPEAN COUNCIL - Conclusions**

**9.12.2011** The European Council set orientations for the further development of its energy policy, as regards completing the internal market, enhancing energy efficiency, developing infrastructure, ensuring coherence in the EU' external relations, and enhancing nuclear safety and security.

### EUROPEAN COMMISSION – Public consultation on Renewable Energy Strategy

**6.12.2011** The European Commission has launched a public consultation on Renewable Energy Strategy. This public consultation has the aim of soliciting the view of interested parties to assess in how far the orientations of the current policy framework remain valid in the medium term until 2030. The public consultation will close on 7 February 2012.

### ACER – Final Framework Guidelines on Electricity System Operation

**6.12.2011** These new guidelines are aimed at setting clear and objective principles for the drafting by ENSTO-E of network codes on electricity system operation. The European Commission will now assess whether ACER's guidelines contribute, like previous ones, to non-discrimination, effective competition and the efficient functioning of the market. If the assessment is positive, the Commission will then instruct ENSTO-E to draft network codes based on ACER's framework guidelines within a period of 12 months.
