ACER: Network Codes for Requirements for Grid Connection Applicable to all Generators

On 13 October, ACER adopted its opinion on the Network Code for Requirements for Grid Connection Applicable to all Generators. In its opinion, ACER highlights a few areas where improvement is needed for the Network Code to be fully in line with the Framework Guidelines and hence recommended for adoption to the European Commission. The main areas of concern are the significance test, the justification of significant deviations, national scrutiny and cost recovery.
