EUROPEAN Parliament – Trans-European energy networks

On 18 December 2012, the ITRE Committee of the European Parliament adopted the report on the trans-European energy infrastructure package. The regulation determines the criteria for Projects of Common Interest for European energy infrastructure. Requirements for

smart grid projects to receive PCI status being transmission grid oriented, the regulation misses the opportunity to bring much needed local and regional distribution grid projects into the investment focus.

The directive on concessions will be put to vote in IMCO Committee of the European Parliament on 24 January 2013.

IMCO coordinators will decide at a later stage whether to open

negociations with the Council for a first-reading agreement or to submit the IMCO report (Rapporteur: P. Juvin) to plenary.

The Council took note of a progress report on the follow-up to the 2011 February European Council's conclusions on energy, and held an exchange of views on the progress achieved.
