### EUROPEAN PARLIAMENT - The Energy Roadmap 2050, a future with energy

During its meeting of 24 January, ITRE members adopted the report "The Energy Roadmap 2050, a future with energy", after the Rapporteur, Niki Tzavela, and the Shadow rapporteurs had reached an agreement on a high number of com-

promises amendments. The vote in plenary session is expected on 11 March 2013.

### EUROPEAN PARLIAMENT – Concessions

On 24 January, members of the IMCO Committee adopted approximately 153 amendments, of which 115 compromise amendments reached between the Rapporteur (Philippe Juvin) and Shadows. The compromises partly reflected those supported in the two public procurement directives ('classic' and 'utilities'), which were voted on 18 December 2012 and on 24 January re-

spectively. Coordinators will decide at a later stage whether to open negotiations with the Council for an early first-reading agreement on the entire public procurement package, or to submit the IMCO report to the plenary which is expected on 22 May 2013. ### EUROPEAN COMMISSION – Proposal for a directive on the deployment of alternative fuels infrastructure

On 24 January, the European Commission (DG MOVE) announced an ambitious package of measures to ensure the build-up of alternative fuel stations across Europe, with common standards for their design and use. Policy initiatives so far have mostly ad-

dressed the actual fuels and vehicles, without considering the deployment of infrastructure for fuels distribution. See the main proposed measures:

## EUROPEAN PARLIAMENT– Study on Energy Efficiency and the ETS

The recently adopted Energy Efficiency Directive, other EU and Member State level policy instruments on energy efficiency and greenhouse gas emissions trading systems will have interactions with the EU Emissions Trading System. These are analyzed in a study of the ITRE Committee, highlighting possible problems with conflicting or mis-

aligned policy instruments. It provides recommendations on the design of policy instruments, in particular the Emissions Trading System.
